**Htigiet dwar Standards u Prattika dwar il-Prezz ta' Telefonati u SMS's fil-Mezzi tax-Xandir**

**Titolu**

It-titulu ta' dawn il-htigiet huwa Htigiet dwar *Standards* u Prattika dwar il-Prezz ta' Telefonati u SMS's fil-Mezzi tax-Xandir.

**1. Introduzzjoni**

Dawn il-Htigiet dwar Standards u Prattika saru mill-Autorità tax-Xandir bis-saħħha ta' l-artikolu 20(3) ta' l-Att dwar ix-Xandir, Kapitolu 350 tal-Liġijiet ta' Malta.

**2. Il-Prezz tat-Telefonata u ta' SMS għandu jixxandar**

Meta l-prezz tat-telefonata jew ta' l-SMS ikun ogħla mit-tariffa normali pubblikata, ix-xandar għandu jinforma li-telespettatur u lis-semmiegħ, skond il-każ, kemm huwa l-prezz ta' dik it-telefonata jew SMS.

Jekk xi parti mill-ħlas tat-telefonata jew ta' l-SMS, skond il-każ, se tingħata għal xi kawża li minnha mhux se isir qligh, din il-parti trid tkun ukoll speċifikata.

Fil-każ ta' programm televiżiv, l-informazzjoni msemmija fil-paragrafi 2.1 and 2.2 għandha tingħata permezz ta' *caption* li għandha tikkonforma mal-Htigiet dwar *Standards* u Prattika dwar Sottotitli u Titli Oħrajn fil-Programmi Televiżivi.

Dawn il-Htigiet japplikaw għal kull programm imxandar fuq ir-radju u t-televiżjoni.

**3. Rispett ghall-privatezza tal-persuna li ċċempel waqt telefonati.**

Il-preżentaturi tar-radju u tat-televiżjoni għandhom joqogħdu attenti meta jitkellmu ma' persuni fuq it-telefon waqt programmi tar-radju u tat-televiżjoni sabiex jiżguraw illi ma jkun hemm l-ebda invażjoni eċċessiva tal-privatezza tal-persuna li ċċempel.

B'mod partikolari, il-preżentaturi tar-radju u tat-televiżjoni għandhom jevitaw isaqsu mistoqsijiet li għalkemm mad-daqqa t'għajnej jidher innokwi xorta jikkostitw x Xuksimon tal-privatezza ta' xi ħadd bħal meta jistaqsu lill-persuna li ċċempel jekk tkun qed tgħix waħedha jew ma' persuna oħra.

**BROADCASTING ACT  
(CAP. 350)**

**Requirements as to Standards and Practice Applicable to the Price of Telephone Calls and Sms's in the Broadcasting Media**

**Citation**

The title of these requirements is the Requirements as to Standards and Practice applicable to the Price of Telephone Calls and SMS's in the Broadcasting Media.

**1. Purpose**

These Requirements as to Standards and Practice have been made by the Broadcasting Authority in virtue of article 20(3) of the Broadcasting Act, Chapter 350 of the Laws of Malta.

**2. Cost of Telephone Call and SMS to be made known**

Where the cost of a telephone call or sms is higher than the normal published tariff, then the broadcaster has to inform the viewer or listener, as the case may be, of the price of that phone call or sms.

If a proportion of the cost of the call or sms, as the case may be, is intended for any non-profit making cause, then that proportion must also be specified.

In the case of a television programme, the information referred to in paragraphs 2.1 and 2.2 shall be given by means of a caption which shall comply with the Requirements as to Standards and Practice applicable to Crawls and Captions in Television Programmes.

These Requirements apply to any programme broadcast on radio and television.

**3. Respect for caller's privacy during phone calls**

Radio and television presenters should be careful when speaking to people over the phone during radio and television programmes in order to ensure that there is no undue invasion of the caller's privacy.

In particular, radio and television presenters should avoid asking questions which although at face value appear innocuous, could still constitute an infringement of one's privacy such as whether the caller is living alone or with other persons.

**4. Revocation of Government Notice No. 458 of 2007.**

Government Notice 458 of 2007 is hereby revoked.
